Foundation Overview

Mistaken Identity was founded in March 2016 and in the short time since then and now, we have had the honor of serving 200 participants in the State of Maryland. We have accomplished this by partnering with and administering the M.I. Program for:

- Baltimore City Community College (Warehouse Inventory Control Associate (WICA) Training Program
- Prince George's County State Attorney's Office (Back on Track (BOT) Program)
- City of Seat Pleasant Mayor's Office
- Prince George's County Juvenile Courts
- Community walk-in participants

Through our programming and the above partners, we have created increased awareness in the community regarding the value of a "second chance" for misguided young adults and formerly incarcerated individuals. We have helped prove all citizens can be successful if given the right set of workforce development and social-emotional skills.

In 2017, Mistaken Identity partnered with several more organizations with similar mission. *Our most relevant partnership in relations to vocational training is with Penn Foster.* Penn Foster is a regional and national recognized accredited career school that provides Mistaken Identity with curriculum, technical support, an online student community and externship training programs with nationally recognized corporations such as CVS Pharmacy, Walgreens, Bright Horizons childcare, VCA Animal Hospitals and more. *We combine their educational curriculum and platform and our computer lab to provide a consistent and monitored learning environment for any of the eleven (11) industry-recognized certifications.*

In 2017 and 2018 we have continued to partner and obtain MOUs with community and national organizations that have similar missions and objectives enabling us to leverage each other's knowledge, technical abilities and contacts allowing for a greater impact on the community. They are:

- Eckerd Connects Workforce Development
- Volunteers of America Chesapeake
- Girls Scouts of America National Capital Area Council
- The City of Seat Pleasant's Mayor's Office

The combined efforts of our partnerships as well as our local and virtual team provide a dynamic community and a new healthy, supportive dimension to anyone's educational experience.

Program statistics are:

- 2016/2017 served over 240 participants
 - 75% successfully completed our program
 - o 85% obtained jobs in their field of study
 - o 90% have retained these jobs without incident for 90 days or more.
- 2018 on track to service over 500 community members
- 2019 estimated to support over 1200 constituents
